Dear Exhibitors,

In the coming months towards the IWA World Water Congress & Exhibition 2022 (IWA WWCE2022) we will send you regular updates on various aspects of your participation as exhibitor in this global water event. All updates will be numbered, so you can easily file them and keep track on progress.

1. IMPORTANT - REGISTRATION PROCEDURE / OPTIONS:

Please be informed that we have different kinds of registrations:

Delegate badges	Exhibitor badges	Visitor badges
These badges give access to all congress sessions and the exhibit. See below for more information (Ad. 1). We already sent you this information in Update nr. 1, below a copy of that information.	These are for staff in the booths in the Exhibition. These badges are free of charge and give you access to the exhibition floor. With the exhibitor pass, you are also able to attend the Business Forum sessions. More info below (Ad. 2).	Free of charge. You can use the Visitors Invitations to invite your relations to visit the Exhibition. The visitor pass gives free access to the exhibition floor and Business Forum sessions during opening hours. More information on the visitor registration will follow in Update nr. 3 (next week)

CONGRESS REGISTRATION:

The registration for Congress delegates has opened recently. Exhibitors are entitled to order a limited number of **discounted** Congress Registrations for the fee of €602,50 (excl. VAT) per registration instead of the regular fee of €1205,- (excl. VAT) with following limitations;

Stands 9 sqm. up to 20 sq.m.: 2 discounted registrations
Stands 21 sqm. up to 50 sq.m.: 3 discounted registrations
Stands 51 sqm. and more: 4 discounted registrations

Please follow this process:

1. Please send a reply to info@iwa-exhibitions.com to indicate your interest in these discounted tickets (and indicate how many you need)
2. After that you will receive an e-mail from us, including a discount code and a link to the registration website
3. Then follow the instructions on the registration website
4. The deadline for ordering your discounted delegate badges is **1 July 2022**, but we advise you to order as soon as possible to secure your badges

Note: the above is about registration as a **congress delegate**, which allows you to attend all sessions, access to congress lunches. This is not mandatory, it does however offer you good content and networking possibilities.

EXHIBITOR REGISTRATION

All personnel in the exhibition hall must wear identification badges at all times. Exhibitor badges can be collected from the registration desk upon arrival.

To order your exhibitor badges please do following:

3. Send us an e-mail to info@iwa-exhibitions.com with following information:
4. Include the **number of badges** you want to order and include per badge following information: Family name + First name + Job title + Company name + Country
5. You are entitled for a number of badges that relate to your stand size, see table below
6. Please send us your list of exhibitor passes no later than **1 July 2022** (but the sooner the better)

Exhibitors receive complementary exhibitors passes related to the surface of the stand:

1 – 15 sq.m.	4 badges
16 – 30 sq.m.	6 badges
31 – 50 sq.m.	8 badges
> 50 sq.m.	2 badges per 10 sq.m.

Additional badges will be charged with Euro 15,- per badge

Deadline for ordering exhibitor badges is 1 July 2022

2. BUSINESS FORUM SESSIONS:

To highlight your companies projects and innovations, the Business Forums Sessions offer an excellent opportunity. As Exhibitor you can apply for a Business Forum session hosted by your organization.

The Business Forums (BF) are a full component of the Programme of the IWA WWCE 2022 and provide a series of sessions where Sponsors & Exhibitors can invite delegates / trade exhibition visitors and other exhibitors to interact, discuss and learn about new developments and innovations (projects, services, research, challenges, and strategic direction) of single companies and countries.
